1707 May 29. Very stained and faded what appears to be a description of land with penciled map on another sheet.

No Date. Ink map with description on Canada Creek on North side of Mohawk.

No Date. About city taking possession of lot on Grass Lane bought of M. Myndun.

1775 April 7 listing of patents and leases but does not say where. Names A. Staats, R. Livingston, W. Van Rensselaer, R. Noble, G. Charters.

1793 June 10. Family letter from T. Diamond to Son William.

1794 December 1. Letter of T. Spencer to unnamed person to forward letter to his father in law.

1775 Jan. 4. P.W. Yates to W. Pemberton and J. Cole, Catskill. Wrote to H. Denniston to discharge execution of Van Bergen and Brand.

1787 September 7. r. Yates to A. Schuyler. About an application for which he wants an opinion.

1761 April 1. Power of Attorney of C. Cormick of Mass. Bay to J. Askin, Albany to collect bills from E. Cole at Detroit.

1774 January 11. Judge R. Esselstyne of Claverack orders J. Van Rensselaer to retake property he was forced from a long list of names.

1775 J. Myers complains to City Court that S. Ruckel has not paid a promissory note.

1651 March 28. 7 pages of book of land records. Names. E. Hallon. T. Hungerford, O. Brown, R. Burros, W. Taylor, J. Gager. Land in marsh at Birchland.

1699 March 14. Hannah Burknot deeds land to sons named P.S. and J. bill.

1712 May 16. Will of J. Berry not signed.

1714 June 10. Testimony of Elizabeth Haines concerning A. Kindcome cutting brush near Captain J. Avery's lot.

1741 May 12. Order appointing D. Pope, P. Taylor, A. Duany, C. Hendley to examine C. Wimbleton, Lieutenant Ship of War Worcester. Not signed.

No Date. Description of boundaries of a number of pieces of land. On margin is J. Dumbleton, Albany Co.

1755 December 25. Receipt of J. Lape to A. Willow for 10 shillings.

- 1760 August 22. Note of W. Bostwick & Wooster to T. Dennis.
- 1764 Handwritten epitaph of a British captain buried in N.Y. Receipt of J. Ogden to J. Berry. Measurement of Van Zandt lot on Washington Street.
- 1765 July 1. D. Ogden recommends D. Burnet and D. Bruen to J. Berry for a loan.
- 1766 July 21. S. Cooke to Dear Brothers in Tribulation. Stained and hard to read.
- 1771 August 19. Order of J. Riggs to any Constable to take chattels of G. Walls. Pay his debts with the funds. Receipt of P. Fields to L. Burger.
- 1774 September 10. Expenses for school on Town Hill. 46 pounds.
- 1775 June 21. Accounts for cloth. Signed A. Austin. Witnessed L. Movodl.
- 1779 November 2. Lieutenant W. Munday About getting provender from Col. Cortlandt.
- 1780 February 28. List of taxes paid into the state treasure. L. Gansevoort, Treasurer, 28,537 pounds.
- 1780 Military record of E. Morgan and list of his estate.
- 1783 January. Sermons of minister.
- 1783 December 20. Accounts of N. Underhill.
- 1786 April 14. Major Stedholm to B. Crannel about partitioning Sir A. Hammond's lands. About it being very unfair.
- 1786 July 24. Sir W. Hamilton, Naples to T. Wedgewood, London. About a Bohemian Vase which he paid 1,000 pounds for.
- 1789 December 24. J. Roorbuck, N.Y. Pell, Esquire. About a suit brought against Mr. Betts by Titus and Demitt over a hogshead of rum.
- 1790 November 27. part of a deed signed by J.S. Hobert, Judge and R. Lush, Clk.
- 1792 May 1. Bond of R. Peckstone of Newark, N.J. to J. Gerritse of Saddle River, N.H.
- 1792 December 27. Receipt of T. Pearsall and Son, N.Y. J. Cooper and J. Palin. Bill of W. Thornton to V. Vermont for wood.
- 1793 April 30. Quit claim deed to B. Sell from Al Alexander.
- 1793 May 14. Note of R. Packstone to J. Sip.
- 1793 July 27. Bill of J. Maunsell to Estate of J. Watkins for law services.
- 1794 September 21. Warrant to S.E. Ayer of 8th Regiment Connecticut Militia to collect fines at court martial with list of names.
- 1798 November 16. Elizabeth Shaw of Nevisink swears J. DeLabarge is father of her child.
- 1762 May 1. Bond of N. Bowdish of Greenwich, R.I. to H. Lord. Receipt of J. Glen to H. Hansen for 5 oxen.

- 1755 December 26. Note of J. Phillips of Boston to N. Stanton and C. Tyler. Note of J. French of N.Y. to J. Gill. Note, E. Lord to N. Gates.
- 1763 November 1. Receipt of W McGraw to W. Tillibagh for 2 oxen. Bill of constable G. Nestel of Canajoharie, signed A. Lauks, Justice.
- 1770 September 22. Receipt of J. Fay of Bennington to G. Fonda as administrator of estate of H. Lord.
- 1796 February 15. Notice A. Mann paid on J. Lewis bond. Receipt, name torn out for rent paid by S. Cummings for farm in Ballston. Witness, A. Hun.
- 1787 October 1. J. Oliver and F. Merkle give E. Merkle power to collect debt from S. Merkle.
- 1751 June 1. Agreement to divide the lands in the Saratoga Patent Names. P. Schuyler, R. Livingston, J. Schuyler, D. W. Ten Broeck.
- 1753 April 14. Apprentice certificate of B. Strange to Al Wilbur of Little Compton, R. L.

Parchment document of King George too faded to read.
