# **Biography/History Note**

Abraham Lincoln Lewis worked as an architect in the Albany, N.Y. area from 1934 until 1985. He holds a teaching certificate from the City of New York dated June 24, 1921 and a diploma from the Hebrew Technical Institute for instruction in Mechanic Arts from June 4, 1924. He was employed by the New York State Department of Public Works (NYSDPW) from 1934 until 1966. He began as an assistant architect. In 1948 he became a senior architect. From 1953 until he left NYSDPW in 1966 he was an associate architect.

Lewis began working for himself in 1967 at 85 Watervliet Avenue, Albany, N.Y. and in 1969 he joined forces to create Lewis & O'Connor, Architects. (He also worked together on area projects with the architects Julius Tauss, O. Fuchs, Joseph T. Hammer, Peter W. Pagano and as Lewis & McGrath.) In 1970 he had his own company, A.L. Lewis Associated Architects, which he maintained until 1974. He then retired for a short time. In 1981 he began working again as an employee of Harris A. Sanders Associates at 40 Colvin Avenue, Albany, N.Y. and remained there until he permanently retired in 1986.

While working for NYSDPW, A.L. Lewis also designed independently. In February 1954 he designed a home for Dr. and Mrs. Irving S. Dribben in Loudonville, NY. From March 1954 until June 1956 he designed a series of supermarkets called Empire Supermarket for Wappingers Falls, Poughkeepsie, Rhinebeck, New Paltz, and Glens Falls, New York.

After leaving NYSDPW, A.L. Lewis was productive as an independent architect in the Albany, N.Y. area. He began drawings in 1965 for a well-known Albany area shopping plaza, Stuyvesant Plaza. These drawings date from 1965-1967 and 1970. He and associate architect Peter W. Pagano were responsible for the development of the entire plaza and the nearby L'Ecole Restaurant.

Lewis contributed to the development of State Street and Washington Avenue (Albany, N.Y.) corporate buildings with his designs for Mechanic's Exchange Bank at 111 Washington Avenue. He collaborated on the building with the architect Julius Tauss from 1961-1962, and 1973. A large portion of the corporate drawings in the collection center around the design of a ten story office building at 54 State Street for National Commercial Bank, now Key Bank. These drawings date from 1971-1973 and 1975. In 1973 he designed alterations for Urbach Kahn and Werlin at 66 State Street and for 70-72 State Street.

A.L. Lewis also contributed to the development of buildings for smaller area businesses in Albany, N.Y. These include an office building on Fuller Road for Glens Falls Insurance in 1964, The Albany Central Federation of Labor Temple at 890 Third Street, (1965-1966), West Albany Industrial Warehouse Development (1969 and 1972), Albany Public Market in Rensselaer (1972-73) and Wolberg Electric Warehouse (1967 and 1973 as Lewis & O'Connor).

A.L. Lewis resided in Albany, N.Y. with his wife Marjorie at 54 Pinewood Avenue from 1934 until 1936 and then at 84 1/2 Sycamore Street until 1964 when they moved to Florida.

#### **Scope and Content Note**

The A.L. Lewis Collection of Architectural Drawings, 1921-1975, predominantly consists of architectural plans for Albany, N.Y. area building development dating from 1954 to 1975. Plans include corporate buildings such as National Commercial Bank, Mechanics Exchange Savings Bank and Stuyvesant Plaza. There are also drawings for smaller area business developments. In addition, the collection contains business papers outlining contract agreements from 1956 to 1958 for the building of Stuyvesant Plaza. Included are photos of renderings and realty brochures of completed buildings. Lewis' personal life is not covered in the collection. The Albany City Directory however, outlines a long map of his career as an Albany architect.
