# From the Executive Director



Thank you to everyone who helped the Albany Institute of History & Art to commemorate a significant milestone---the museum's 225<sup>th</sup> anniversary.

We celebrated the year in style with exhibitions ranging from "Masterworks" and Alexander Hamilton to Rock & Roll Icons, special programming, a new café, art-making activities for people of all ages, a new program for people with Alzheimer's, community partnerships, and special events such as Hudson Valley Hops, Mummy Birthday, and the Gala. Throughout the year, the museum

offered \$2.25 admission on Saturdays as a birthday gift to our patrons. We also created a new timeline highlighting the people, events, and objects that shaped the 225 year history of New York State's oldest museum, which can be viewed on our website.

In 2016 we welcomed 33,970 people to the museum, an increase of almost 9,000 people over 2015. The museum's digital audience has expanded as virtual access to our collections, online exhibitions, and school curriculum materials has increased. Our membership increased by 11%, bucking the national trend. Participation in our art-making activities such as Art for All increased by 93% and 49% for Tute for Tots after revamping program offering and times. Contributions to the museum's operations and special projects rose dramatically.

Technology advancements included Wi-Fi in the galleries and public spaces and a new Smart Board and document camera for the classroom. If you visit our page on the Goggle Cultural Institute, you can take a virtual tour of our galleries. With funding from the New York State Council on the Arts, we installed LED lighting in the galleries, resulting in an annual savings of \$9,000.

In addition to coverage in the local media market, the Albany Institute was featured in an article about the 225<sup>th</sup> anniversary in Antiques & Fine Art magazine, enjoyed coverage of the exhibition Rock & Roll Icons: Photographs by Patrick Harbron by The Guardian, and even had a digital billboard advertisement in Times Square in December. We continue to reach more audiences as our social media presence grows on Facebook, Twitter, and Instagram.

A story that still stands out in 2016 is The Capital Region in 50 Objects, a community-based exhibition designed to tell the story of the people, places, and events that define the Capital Region. This popular exhibition grew "legs," which extends the life of the story. After the exhibition closed we published an award-wining Teacher Resources Guide highlighting objects to the New York State Curriculum standards, we published a 112 page color book, *New York's Capital Region in 50 Objects*, and launched the online exhibition with links to the websites of our 29 lenders. Now people all over the world can read and access the 50 Objects stories at home, work and in schools.

As our future depends on our continued efforts to engage new audiences, expand our programming to schools and communities and broaden our financial base, we look forward to your ongoing interest and support in 2017. Thank you again for celebrating our anniversary year with us. Without you and your enthusiasm, we would not have reached this impressive milestone.

In 2016, we celebrated our commitment to our community and asked everyone to help celebrate our 225<sup>th</sup> Anniversary as the oldest museum in New York State and second oldest museum in the country.

In **January**, we decorated the museum for our year-long celebration with anniversary banners, photographic murals, and tulip motifs. Visitors enjoyed our featured exhibition Masterworks: 225 Years of Collecting, which was drawn from our rich collection of museum icons, new discoveries, and rarely seen treasures.

In **February**, we welcomed press, elected officials, and community members to help celebrate the day the museum was founded in 1791. George Washington (who was President when the museum was founded) came by to cut our historic "birthday" cake with his saber.

Crisan Café opened in **March** and now visitors to the museum can enjoy delicious pastries, savory sandwiches and treats, and a wonderful cup of coffee or tea. It has been a welcome addition to the neighborhood as well.

In **April**, we opened Masterworks: Paper, which featured light-sensitive and seldom-seen materials made of paper and included three-dimensional objects such as a nineteenth-century Chinese "Fan of a Thousand Faces."



In **June**, we held our spectacular 225<sup>th</sup> anniversary Gala at the home of Bernie and Katie Conners with entertainment by the Musicians of Ma'alwyck, Albany Pro Musica, and Opera Saratoga. We capped off the evening with dancing and fabulous fireworks.

Over the **summer**, we joined the Hamilton craze and opened Spotlight: Alexander Hamilton. The exhibition featured a premier (but rarely seen) portrait of Alexander Hamilton from the collection of Union College, a silver tankard from Fort Ticonderoga, and unexpected finds from our collections. We even opened a small exhibit on Aaron Burr showcasing materials from our library collections! We partnered with the Albany County Convention & Visitors Bureau and Schuyler Mansion to welcome guests to Albany who were curious about the Founding Father. We also worked with WMHT to help create their documentary Hamilton's Albany.

In the **fall**, we collaborated with Partners for Albany Stories (PASt) to offer "Pull Up a Chair", a series of interpretive stories and events that looked at historic "seats" in Albany. The initiative was tied to the opening of the traveling exhibition The Art of Seating: 200 Years of American Design. This "PAStport to History" included an admission incentive for visiting multiple sites and will be used as a prototype for partnerships in the future.

Longtime patrons, Don and Anne Eberle, commissioned well-known historical painter Len Tantillo to create a painting and donate it to the museum in honor of their 60<sup>th</sup> wedding anniversary. In **October**, we opened a special exhibition that highlighted the story of the making of the painting, which is called The 1748 Arrival of Governor George Clinton.

**November** started with our fall fundraiser, Work of Art, and concluded with our free admission weekend known as Home for the Holidays. This year, we welcomed 3,200 visitors of all ages to the museum during Home for the Holidays, twice as many last year. A new favorite feature of the weekend was a special exhibition of miniature dioramas by author and illustrator Joan Steiner, which she used for her awardwinning Look-A-Likes® books.

In **December** our members, donors, social media friends, and the community voted every day to help place us in the top ten of the *Times Union* Capital Region Gives contest, which enabled us to win a \$10,000 marketing grant for 2017. We took time to thank our wonderful volunteers for their hours of dedication, remarkable talents, and endless enthusiasm.

# **Exhibitions**

### The Capital Region in 50 Objects

#### September 19, 2015-April 3, 2016

Each region of the country has its own distinctive history and culture that set it apart from others. The Capital Region of New York—consisting of Albany, Rensselaer, Schenectady, and Saratoga Counties— is no different. The process of selecting fifty objects to represent the diverse history of the region was not easy, but thanks to the participation of numerous museums, historical societies, business entities, and private individuals, the Institute was able to assemble fifty objects that told an amazing four hundred year story.



# Abraham Lincoln: The Albany Connections

#### September 26, 2015 – September 11, 2016

Abraham Lincoln visited Albany on February 18, 1861 on his way from Springfield, Illinois, to Washington for his March 4 inauguration as the country's sixteenth president. Lincolns' second visit was on April 26, 1865, as his special funeral train retraced most of the 1,654-mile route the president-elect had made just four years before. This exhibition featured items from the Albany Institute's library collections.

# Masterworks: 225 Years of Collecting

#### November 21, 2015-September 4, 2016

To celebrate the 225th milestone anniversary, this exhibition presented works from the Institute's collection of exceptional artistic merit and craftsmanship that were made in the Upper Hudson Valley or brought to the region by patrons, consumers, collectors, and connoisseurs. The exhibition, which included a timeline of the Institute's 225-year history embedded with objects and images of influential individuals and important acquisitions, also revealed stories about how the



Institute assembled some of its best-known collections, such as its Hudson River School paintings, holdings of regional silver, the familiar cast iron stoves, and the significant collection of early Dutch portraits and scripture paintings. The history of these collections narrates the growth and development of one of the nation's oldest museums and reflects broader trends in American culture and society.

### Masterworks: Paper

#### April 30, 2016-October 16, 2016

In honor of the Albany Institute of History & Art's 225th anniversary, the Masterworks: Paper exhibition combined rarely seen items from the Institute's library collections with prints, drawings, pastels, and watercolors. Masterworks: Paper highlighted seldom-seen materials that cannot be exhibited often or for extended periods of time due to their sensitivity to light. Manuscripts, letters, architectural plans, photographs, ephemera, silhouettes, and maps spanning three



centuries were featured along with works by American masters including artists Thomas Cole, Walter Launt Palmer, and Ellsworth Kelly, industrial designer Henry Dreyfuss, and muralist Lewis W. Rubenstein. Because the world of paper is not just flat, two-dimensional pieces were joined by three-dimensional objects such as books and a nineteenth-century Chinese "Fan of a Thousand Faces."

## **Spotlight: Alexander Hamilton**

June 22, 2016-March 5, 2017

Founding father Alexander Hamilton (1757-1804) first visited Albany in 1777 to speak to General Horatio Gates on behalf of George Washington. Three years later he married Elizabeth Schuyler in the parlor of her Albany home, the Pastures, now known as Schuyler Mansion. For the next 20 years, Hamilton was connected to Albany traveling to the city to visit his in-laws and conducting legal business. This exhibition highlighted objects related to Alexander Hamilton from the



collection with a few loans including a portrait of him by Ezra Ames courtesy of the Union College Permanent Collection, Schenectady, New York and a silver tankard from the Fort Ticonderoga Museum.

#### Fellow Citizen: Aaron Burr

#### Opened September 16, 2016

Aaron Burr (1756-1836) is remembered today largely because of the 1804 duel in which he fatally wounded Alexander Hamilton. This famous foe also had significant ties to Albany, New York—personally, professionally, and politically. This small exhibition is drawn entirely from the museum's manuscript and political broadside collection.

# The Art of Seating: Two Hundred Years of American Design

#### October 1, 2016-December 31, 2016

The Art of Seating, organized by The Museum of Contemporary Art, Jacksonville, in collaboration with the Thomas H. and Diane DeMell Jacobsen Ph.D. Foundation and toured by International Arts & Artists, Washington, D.C., presented exceptional American chair designs from the early nineteenth century to the present day. The chair is experienced not only as a functional item, but as sculptural in view—the chair as art. Each of the more than forty chairs was



chosen for its beauty and historical context with important social, economic, political, and cultural influences. Chairs were selected from the Jacobsen Collection of American Art which were joined by contemporary designs offering a stylistic journey in furniture with chairs by John Henry Belter, George Hunzinger, Herter Brothers, Stickley Brothers, Frank Lloyd Wright, Charles and Ray Eames, Eero Saarinen, Isamu Noguchi, and Frank Gehry, and many others.

# The 1748 Arrival of Governor George Clinton: A New Painting by Len Tantillo

#### October 22, 2016-January 29, 2017

This installation focused on a single painting and its making, The Arrival of Governor George Clinton. Rensselaer County artist Len Tantillo, recounted the process of choosing and reconstructing the painting's historically accurate event, the arrival of New York colonial governor George Clinton at Albany's waterfront, an event that occurred three separate times during the 1740s and 1750s. A selection of historical objects, maps, and an interactive digital recreation of Albany during the middle of the eighteenth century, derived from a recently discovered map in the British Library, allowed visitors the opportunity to follow along on the trail of discovery and recreation.

# Rock & Roll Icons: Photographs by Patrick Harbron

#### November 5, 2016-February 12, 2017

The Rock and Roll Icons: Photographs by Patrick Harbron exhibition used images from Capital region resident Patrick Harbron's body of concert and portrait photography of influential musicians and groups of the 1970's and 1980's, captured at pivotal moments in their careers. The exhibition featured many never published or exhibited photographs. Harbron photographed artists such as Blondie, Rush, Stevie Ray Vaughn, The Police, Bruce Springsteen, Madonna and



Elvis Costello early in their careers, following these artists to prominence and others that were already well known including The Rolling Stones, Pink Floyd, Led Zeppelin, Van Halen, Eric Clapton, David Bowie, Queen, The Who, Genesis, KISS, U2, Aerosmith, and Prince. The exhibition also included Harbron's collection of posters and ephemera gathered throughout his career along with guitars borrowed from the Rock and Roll Hall of Fame.

# Joan Steiner's Look-Alikes®

#### November 25, 2016 - January 29, 2017

Ten miniature dioramas, meticulously crafted scenes created from everyday objects and edible treats, and photographed for Joan Steiner's *Look-Alikes ®* books by the award-willing illustrator Joan Steiner, were exhibited in different locations throughout the museum, offering fun for all ages. Steiner created her three-dimensional dioramas in her Hudson, New York studio, not far from her home in Claverack. Steiner's first book, *Look-Alikes ®*, was published in 1998, and named one of Time Magazine's best children's books and one of The New



York Times Book Review's Notable Children's Books of 1998. The series continued with three other books: *Look-Alikes ® Jr., Look-Alikes ® Christmas,* and *Look-Alikes® Around the World.* 

# **Education Programs**

The mission of the Education Department is to connect our community to our collections and exhibitions through lifelong learning opportunities.

In 2016, our education staff offered a total of 384 programs to 10,981 audience members.

## **School Programs**

We welcomed 3,522 students from 14 New York State counties and 28 school districts to 149 school programs in 2016. Ancient Egyptian Art and Artifacts continues to be our most popular program accounting for 59% of our tours, followed in popularity by Traders and Culture and 50 Objects, each with 5%.

Book Arts, our Arts-in-Education partnership with the City School Districts of Troy and Albany served 6 schools. A total of 30 teachers and 597 students participated in this partnership, which combined classroom visits, art making, gallery activities, and library investigations. Book Arts visits to the Albany Institute accounted for 31% of student visits in 2016. Over 3,000 students have participated in the program in the eleven years since its inception in 2006.

As part of the exhibition The Capital Region in 50 Objects, the Education Department completed an object-based curriculum packet for teachers and educators. The teacher resource is a set of 18 lessons with digital

reproductions and supporting materials that introduce students to the history and culture of the Capital Region of New York through objectbased learning. Education Department staff conducted 4 teacher workshops and attended 2 professional conferences distributing over 180 curriculum packets to teachers throughout the Hudson Valley and New York State in 2016. The lesson plans are available on our website and can be used with any classroom technology in conjunction with the online exhibition.



City School District of Albany Elementary Art Show

On May 6, 448 people attended the opening reception for the 3rd annual City School District of Albany Elementary Art Show. Student musical performances were held throughout the galleries during the reception. Student artwork from 12 schools was on view from Friday, May 6 to Sunday, May 8, 2016.

In 2016 the Review
Foundation awarded the
Albany Institute a 3-year,
\$45,000 grant to support
education programs. This
grant will allow the Education
Department to provide free
field trips to 4<sup>th</sup>, 5<sup>th</sup>, and 6<sup>th</sup>
grade classes from Title 1
Schools in Albany, Rensselaer,

Saratoga, and Schenectady counties during the 2017-2018 through 2019-2020 school years. This opportunity will be promoted among eligible schools in spring 2017 with field trips beginning in fall 2017.

### Family Programs

3,231 adults, children and families came to the Albany Institute in 2016 to participate in the 90 informal learning programs that were offered.

Art for All programs are free with museum admission on Saturdays, October through May. The activity changes monthly and many families plan their museum visits to correspond with the art projects offered. Activities included techniques like painting, sculpture, and collage. In 2016 we welcomed 693 people on 28 Saturdays, representing a 93% increase in participation over 2015.

Two series of programs are conducted for families in the summer. 'Tute for Tots offers parents and children aged 3 to 5 the opportunity to explore the museum's galleries, read stories, explore sensory play, and create exciting art projects. The 9 Friday

morning programs engaged 100 children and their accompanying parent/guardian, representing a participation increase of 49% over 2015. Artful Mornings programs offer children the opportunity to create vibrant works of art inspired by our exhibitions and permanent collections. A total of 27 programs offered 3 days each week were attended by 330 children aged 6-12.

In art programs held during February, April, and December school recesses students aged 6 to 12 explored the Institute's galleries and experimented with a variety of media while learning about the elements and principles of art and design. A total of 107 children participated in 9 programs during 2016.

We engaged 1,946 participants in 15 Family Days throughout the year, including Rock & Roll LEGO® Building Challenge; Mummy Birthday; as well as other exhibition-related programs and performances including Habitat Helpers Family Day and Build It! Chair Design Art Challenge. Art making activities were offered on free

holiday Mondays including Martin Luther King Jr. Day, President's Day, Columbus Day and Veteran's Day. Other special family programs included a Dance Story Hour and Creative Movement Workshop with Ellen Sinopoli Dance Company.

### **Public Programs**

A total of 138 programs including lectures, gallery talks, adult tours, and outreach programs engaged 3,064 participants from our local community and beyond.

In 2016 special lectures celebrated the Albany Institute's 225<sup>th</sup> anniversary. To begin the year, Executive Director Tammis K. Groft presented The Evolution of a Museum: The Albany Institute Celebrates its 225th Anniversary and we hosted Pulitzer Prize-winning novelist William Kennedy for the program *Old Albany* through the Eyes of William Kennedy's Fictional *Characters*. With the support of Humanities New York we welcomed four prominent scholars for the lecture series America in the Late Eighteenth Century. Susan Rather, University of Texas-Austin; Mary Beth Norton, Cornell University; Elisa New, Harvard University; and John Dixon, the College of Staten Island discussed the cultural, political, artistic, literary, and intellectual atmosphere that existed in the United States during the Albany Institute's first years.

In honor of Martin Luther King Jr. Day the museum hosted a screening of the documentary film *The* Brothers: The Forgotten Struggle for Civil Rights in Albany about an activist group called The Brothers and Albany's history with the Civil Rights Movement. Following the film, community members participated in a panel discussion about the civil rights struggle in Albany with original members of the Brothers group. Current issues related to civil and human rights were also brought up in a lively discourse. Over 150 people packed the room to see the film and join in the conversation about community relations.

The Capital Region in 50 Objects included programs led by partner lenders to the exhibition. Kathryn Sheehan, Rensselaer County and Troy City Historian, and Rensselaer County Historical Society Registrar presented Representing Rensselaer County. In Revealing Albany Beverly Bardequez, Rapp Road Historical Association, Jennifer Lemak and Brad Utter. New York State Museum, and Anthony J. Poalka, Albany City Historian discussed the most intriguing

objects in the exhibition. Richard Hendrick, general manager of the Port of Albany, led a guided tour exploring the Port of Albany.

In September, Anja Adriaans traveled from the Netherlands to Albany to discuss her work rediscovering a forgotten episode from our local. national, and international history. Her program *The* Albany Aid Campaign for Nijmegen 1947 highlighted the relief efforts of Albany citizens following World War II to support the city of Nijmegen in the Netherlands. This program included a screening of a long-lost film about the relief efforts and kicked off events to commemorate the 70<sup>th</sup> anniversary of the campaign in 2017.

A lecture series about the exhibition The Art of Seating examined how a piece of common furniture, the chair, can be seen not only as a functional item, but as a work of art and historical object. Ben Thompson, Exhibition Curator and Curator at the Museum of Contemporary Art in Jacksonville, Florida, discussed the process of curating the show and highlighted selections from the collection. Artists Vivian Beer, and Jon Brooks presented overviews of their work and discussed Beer's Current chair and Brooks' Solid Elm Ball chair, both works featured in the exhibition. With Partners for Albany Stories we welcomed Samantha Hall-Saladino, Education Director at the Shaker Heritage Society as

part of the "Pull Up a Chair" series. Hall-Saladino discussed the history and design of Shaker chairs.

During the summer and fall, weekly gallery talks led visitors through the exhibition *Spotlight: Alexander Hamilton.* The programs, scheduled every Thursday in collaboration with Schuyler Mansion Historic Site, were very popular with adults and families. A total of 100 people attended the 16 gallery talks from July through October.

Egypt remains a popular topic for public programs. Lectures by Daniel Warne and Dr. Sahar Saleem drew large crowds. Warne's lecture Finding Ankefenmut provided insight into the 1891 discovery of the Deir el-Bahri "Bab el-Gasus" tomb and burial materials found there. Dr. Saleem's lecture *Scanning* the Pharaohs discussed the findings from her recent medical scans of the great pharaohs from the New Kingdom.

Artist Len Tantillo discussed the use of artifacts, maps, and historical documents from the Albany Institute's collections to create his work *The 1748*Arrival of Governor George
Clinton.

We designed the Art Connects programs for people affected with early to midstage Alzheimer's and other cognitive deficits with their care givers. We use our collections to renew and build social connections and to inspire reflections and conversations. It does not require a background in art, nor does it rely on memory. Art Connects has been through two pilot implementations: the first in 2014-2015 in partnership with regional Alzheimer service organizations; and the second, which was adapted and revised in response to program assessments, was successfully implemented in March and April of 2016. A total of 70 adults participated in the 8 programs offered in 2016.
