Thomas Suraci has responsibility for the core Database business that Oracle transacts with the State of New York (NYS). During his tenure NYS has adopted Oracle technology for the Statewide Financial Manager System, Enterprise Identity and Access Management System, Enterprise Learning Management System, Medicaid DataWarehouse and the NYS Student DataWarehouse as well as various other critical data systems.

Mr. Suraci joined Oracle after twenty-five years in technology sales and is currently in his ninth fiscal year with their public sector team. During his 33 year career, Mr. Suraci has worked for both small start-ups such as Optivision as well as large corporations including Cisco Systems. He owned his own technology firm early in his career in Silicon Valley, Logical Connections, which focused on local area networks and was eventually sold to International MicroNet Systems. Through his experience he has developed a proven track record of success as evidenced by his current assignment leading the way for State and Local public sector sales and has held the distinction of being the Core DB TSM of the year at Oracle.

He has also been integrally involved in the NYS Technology Forum since 2001 and has served on the advisory board for the NYS CIO conference on numerous occasions. He is a member of the NYS Information Technology Committee Roundtable, (ITCR) as well as Marist College's Technology Advisory Board.
