Titles

Biography/History of

Annesley and Vint were 19th and early 20th century art dealers, frame and furniture makers and artist supply vendors based in the Albany area. Founded in 1802 by Lawson Annesley, whose family was guilders by trade, the first shop opened at 16 Steuben St. in 1813. In 1856 Annesley took on Marshall K. Williamson as a partner at which time the company name was changed to Annesley and Williamson. 1856 was also the first year

that the company advertised their business in Albany Directories. In 1864, after a string of name and partner changes, James Vint, a former salesman for the company became partner. This partnership would last for the next 20 years. During this time, the company gained wide recognition and was extraordinarily prosperous. Annesley and Vint regularly supplied private schools, judges, doctors, photographers, businessmen and politicians such as governor of New York Erastus Corning. In the early 20th century the company advertised itself as a furniture and antiques dealership.

Scope and Contents of the Records/Papers/Collection

This small collection consists of a circular advertising among other things, "rich gilt framed mirrors", a price list for "mahogany and gilt framed looking glasses" and a daybook for the years 1874-1875. The daybook is leather bound and contains hand written records of sales and transactions.

Organization of the Records/Papers/Collection

All material is contained in one manuscript box. The price list and circular are housed in Mylar sleeves within folders.
