Scope and Contents of the Records

The records include correspondence, genealogical records, wills, and deeds. The correspondence deals mostly with genealogy. Besides the Livingstons, there are genealogical records for other prominent local families. There is also an abundance of family wills and deeds in the Livingston family. There are also two copybooks, one from the Patterson family, and one from the Morris family.

Organization of the Records

The records are in three boxes. Box 1 has 15 folders. The contents include correspondence, newspaper articles, wills, deeds, personal papers and some genealogical records. Box 2 contains 10 folders. The contents include 2 copybooks, and genealogical information for the Livingston, Morris, Patterson, Van Cortland, Van Rensselaer, and DePau families. Box 3 contains 5 folders. The contents are all genealogical records of Peter R., Catherine, Maria and Miscellaneous Livingstons.
