## **Scope and Contents of the Records**

The collection consists of calendar dates with names of different parties who did business in the court that year. The names of both plaintiff and defendant are given together with the description of the action brought, and the names of the attorneys for each side and the plea entered. Many familiar Albany names occur in the calendars. There is also a book of receipts paid to the city, reported missing in August of 1991. Finally, there is an order to convene court session.
