Scope and Contents of the Records

The records are primarily legal and personal in nature. They document the daily living of Leonard Gansevoort Jr. The collection also documents his legal career, with folders on different legal cases by year. There is also some correspondence.

Organization of the Records

The records are organized into two different boxes. In box 1, the contents are primarily bills, receipts, and correspondence along with a folder on Hun, Gansevoort, and Bassett family genealogies. Box 2 contains legal cases, and certificates of membership the Albany Library and the New York State Assembly. There is also a folder of indentures.

Related Material

The Hun Family Papers Collection, BK 346 also contains geological references to the Gansevoort family. The Huns and the Gansevoorts were related.

The Gansevoort Ten Eyck Papers, MG 1 have materials on the Gansevoort family.
