Biography/History of

This collection consists mainly of business papers of Francis Patrick Garvan 1875-1937, Assistant D.A. in New York for 1901-1909, later lawyer and chairman of the Chemical Trust Fund Co. He was the son of Massachusetts state senator Patrick Garvan, 1839-1911. He grew up in Hartford, Mass. In 1910 he had married Mabel Brady, 1887-1975, daughter of the Albany tycoon Anthony Nicholas Brady, 1843-1913.

The emphasis of the collection is on papers and files relating to the lifestyle of Patrick and Mabel Garvan. Both belonged to the rich and famous. But they also were the children of fathers who had come as penniless Irish immigrants and risen to wealth.

Included are genealogical papers concerning the ancestry of Marcia Ann Myers Brady, born 1849 in Bennington Vermont, and the research done in Ireland on behalf of Francis Patrick Garvan from 1925-1930. Both include correspondence with genealogical researchers. The application of Mabel Brady Garvan to the Colonial Dame Society gives interesting details about the long procedure, (1930-1935).

Francis P. Garvan and his wife owned extensive properties, most around Hempstead, Nassau County, but also Kamp Kill Kare, Raquette Lake, Washington County. They are represented by papers and files relating to salaries, employees, bills, pet animals, donations local taxes paid, etc.

In 1913 Anthony Brady left his fortune of ca. \$80 million to his four surviving children, Nicholas P. Brady, Frank C. Brady, Mabel Brady Garvan, and Marcia Brady Tucker as a trust fund. His sons were also appointed as trustees. In 1918 the two Brady sisters contested the management of the trust fund, and the biggest court case of the twenties started. In 192? after \$500,000 in legal expenses, the family settled for a compromise. The papers related to that famed "Brady Case" include proceedings, bills and memoranda from New York City and Albany.

Francis P. Garvan studied at Yale, 1893 -1897, and he and his wife donated much art to it. Available is correspondence with art dealers, insurers, museums, etc. mostly from 1920s -1940s.

Some files include minutiae of stock transactions form 1926-1935, with much material from 1929-1930. Francis P. Garvan also managed accounts for clients, for which detailed transaction reports exist.

Scope and Contents of the Records/Papers/Collection

Genealogy Contains three groups of genealogical documents. The first results from research done for the application of Mabel Brady Garvan to the Colonial Dames via her mother, Marcia Myers. The papers contain many references to early colonial settlers and many documents from Pownal and Bennington Vt. This group includes research reports written by professional genealogists to Mr. Garvan as well as correspondence pertaining to the Colonial Dames admission process. The second group is about the Garvan family, and consists of wills, letters, mementos and clippings about the family in Hartford, Ct., ca. 1860-1910, as well of research in Ireland done by Mr. Dunleavy. The areas searched were Castleroche and Dungarvan, Co. Cork. Mr. Dunleavy also interviewed relatives, sent detailed reports and many photos. The Garvan ancestry could be traced till the end of the 18th century. The third group consists of mementos which F.P. Garvan collected about his career. Many newspaper clippings, but also abstracts of his main cases as Assistant D. A. in New York, 1901-1909, reports of his actions as custodian for alien property 1917-1918 and clippings about his death,1937. Also included are reports, articles and pictures about his time at Yale, 1893-1897.

A. N. Brady Estate Anthony Nicholas Brady left most of his \$80 million fortune as trust to his four surviving children. Trustee was the US Trust Company. Due to the "Brady Case", (see introduction) most records pertaining to the administration of the trust are available, like inventories of property, the probate of A. N. Brady's will 1914, lists of stock investments, etc. Many documents relate to the Brady Case. A good introduction to the case is the summary written for Isidor Kressel, Box 8, Folder 7.

Property: In this series are documents pertaining to the ownership and administration of properties owned by Mabel Brady Garvan and Francis Patrick Garvan. The folders are usually arranged by property. The documents are most numerous from 1920-1937. A

Substantial amount of property was owned legally by trust funds, established either by the A. N. Brady or the Patrick Garvan estate; after 1937 they were joined by the trust fund established by F.P. Garvan and administered by the Empire Trust Co. The property records are not filed according to the trust owning them. The series included files relating to salaries and personnel, with several folders about early social security and workmen compensation insurance. The salary files give name and salary of the worker, with notes about the family. The Roslyn and Kamp Kill Kare files are the largest. Other documents deal with all aspects of the administration of a large property, mostly Roslyn, from repairs (many period catalogs) to taxes and landscaping, disputes about the Long Island Parkway, (1924), animals, valuations and maps of Hempstead, L.I. and Raquette Lake from the 20s and 30s, as well as two real estate businesses owned by F.P. Garvan in Long Island. Also included are book and magazine subscription files, (Box 19, correspondence with New York book dealers) art dealers and art ownership, mixed with the other files with some under Ss F.P. Garvan Estate). The Garvan family owned many art objects, most of which were donated to Yale.

The last subseries pertains to the Woodlawn Mausoleum, burial ground of F.P. Garvan and his family with detailed documents about the building and renovation of the Mausoleum, as well as the rental of the plot.

Legal Papers: After retiring as assistant D.A. in 1909, F.P. Garvan opened a law firm with George Corbett, (1882- 1951). During the 20s J. Convoy joined. The series contains materials about several dozen cases worked by the Garvan-Corbett firm, with some cases pertaining to legal questions involving the Garvan family itself.

Taxes: The series contains federal and N.Y. State income tax returns of F.P. Garvan-M.B. Garvan, (joint returns up to 1937), as well as F.P. Garvan Jr and the business tax returns of Garvan-Corbett. The records range from 1915-1952. Included are usually the notes used to prepare the returns, (summaries and inventories of holdings), correspondence with the IRS and legal advice concerning the tax status of certain categories of income. Three audit, 1936,37,39.

Financial Documents: Mostly check stubs and bank statements of F. P. Garvan, and 4 boxes with documents pertaining to stock transactions done by F. P Garvan for himself as well as clients. Very detailed for the period 1926-1932

Miscellaneous: Mabel Brady Garvan, receipted bills 1931,1932, 1937
