#### Biography/History Note

George and Anna Menges, while living at 68 Bassett Street, Albany, N.Y., accumulated years worth of common household papers. The following history of their routine life was deduced from the papers in the collection.

Prior to the Menges' living at 68 Bassett Street, the house was owned by John and Catharine Rothaupt. John and Catharine Rothaupt were the parents of Anna, Dora and Julia.

Anna married George Menges in (April?) 1885. According to the Albany City Directory of 1900, George Menges' name is listed as living in a house at 561 1/2 Clinton Avenue. He is a carpenter. Their names are both listed in the Albany City Directory of 1902 as living at 68 Bassett Street, where George is again listed as a carpenter and Anna as a grocer.

After the deaths of John and Catharine Rothaupt, (John deceased Oct. 3, 1869 and Catharine deceased May 20, 1898), Anna and Dora sold the Bassett Street property to George Menges for fifteen hundred dollars for the entire property. The agreement to this sale, which is in the collection, is not dated but is accompanied by three deeds, dated July 12, 1907, agreeing also to the sale of property adjacent to 68 Bassett Street. This property belonged to the children of Julia (Rothaupt)Dorr, (deceased May 20, 1900), John and Catharine Dorr. Deeds are in the names of Dora C. Rothaupt, John and Catharine Dorr and Christian Dorr their father.

In 1910 a two-story addition is built on to the 68 Bassett Street house. The collection includes instructions for building the addition.

In 1910 George and Anna celebrated their twenty-fifth wedding anniversary. Many of the congratulatory items saved were dated April 1910, which may have been the month of their wedding.

Charles and Caroline Rothaupt, Aunt and Uncle of Anna, Dora and Julia, resided at 78 Cherry Street. (Their name is listed in the Albany City Directory at 70 Cherry Street until 1890 and from then on it is listed at 78 Cherry Street).

On March 4, 1903 George Menges and a Charles F. Schiffendecker, witness a statement made by Caroline Rothaupt, of Albany, N.Y. She declares George Menges executor of her estate. This is accompanied by statements citing her beneficiaries.

An Article of Agreement made on March 10, 1921 between Anna and George Menges and Abraham Meyers describes the sale of 78 Cherry Street to Abraham Meyers for eighteen hundred dollars as of April 1, 1921. How George and Anna Menges originally acquired 78 Cherry Street is not known, however this collection holds many receipts for work done at 78 Cherry Street in the name of George and Anna Menges.

In 1921 George Menges dies. This information is based on a list of funeral expenses from Louis F. Dascher, Funeral Director and Embalmer, dated December 6, 1921.

In 1931, Dora C. Rothaupt comes to live with her sister at 68 Bassett Street until her death in 1936. The collection contains receipts and other documents in the name of Dora C. Rothaupt. Dora is listed at this address as of 1931 in the Albany City Directory. She is also listed as a saleswoman at 47 North Pearl Street.

There is no record of the actual date of death of Mrs. Anna G. Menges in this collection. There are records of time spent in the Albany Hospital on New Scotland Avenue, for unknown reasons, in 1941 or 1942. A woman by the name of Mrs. E. B. Shaper acts as her comptroller on some documents. The last item to date is a receipt for Industrial policies and Premium receipt books to be surrendered with proofs of death, received from Mrs. Shaper, dated January 26, 1944.

According to the Albany City Directory, 68 Bassett Street was last owned by Mrs. Anna G. Menges in 1942. The house remained vacant thereafter until 1947.

#### Scope and Content

The collection consists of an assortment of receipts, notes, letters and other household documents dated between 1898 and 1944 from the home of George and Anna Menges at 68 Bassett Street, Albany, New York. The items collected document personal relationships, property ownership, building renovations and additions, household expenditures, taxes and death in the Menges and Rothaupt families. The contents of the collection are divided into five series: household receipts, renovation and construction receipts, personal correspondence, legal papers, and tax receipts.

The household receipts describe the conversion from coal to oil heating with bills for delivery of coal from R. B. Rock Coal and Ice from 1907 until 1937 and an invoice describing the installation of an oil burner on December 31, 1936 by John C.

Manifold, Plumbing and Heating and oil delivery by Standard Oil of New York. The invoice from John C. Manifold also describes the installation of a radiator and a hot water boiler in 1936.

The house at 68 Bassett Street underwent many changes between the years 1905 and 1936. Detailed receipts describe building and maintenance work of twelve different laborers over this thirty-year period. Receipts from Joseph O. Stapf, Plumbing and Roofing, span almost twenty years from the installation of eighty square feet of tin roof in 1910 to periodic plumbing maintenance until 1938. In 1910 a two-story frame addition was constructed by William L. Geotze, Carpenter and Builder. Materials for renovations were supplied by Welsh and Grey Lumber through the years of 1910 and 1935. From 1905 until 1925 wallpapering services were bought from J. G. & F Held. Various other laborers made alterations at 68 Bassett Street and 78 Cherry Street.

Personal correspondence can be found in the form of a letter from a friend of Anna Menges in So. Bethlehem dated Feb. 7, 1900. There are congratulatory letters, telegrams and gift tags for the celebration of George and Anna's twenty-fifth wedding anniversary in 1910. A hand written receipt on a scrap of paper notes the purchase of a piano for the sum of seventy-five dollars on Sept. 3, 1912. Doctor visits, church envelops, a wedding clipping, rent receipts, a list of deposits and disbursements and a letter to Dora C. Rothaupt from Capitol City Lodge No. 440 are dated between 1900 to 1942.

The legal papers include deeds of property which tell how 68 Bassett Street was acquired by Anna and George Menges. The collection contains family wills, bankbooks and insurance policies. These documents describe members of the Menges and Rothaupt families and their relationship to George and Anna Menges. Funerals are recorded by receipts from Louis F. Dascher, Funeral Director and Embalmer; the collection contains lists of expenses for three burials dating 1912, 1921, and 1925.

Tax records retained show payments made to the City of Albany for water rents, street improvements and city taxes from 1898 to 1939. Payments received by the city, paid to the Bureau of Water, from 1898-99 and water rents for 1904 came from John He also paid for street repairs from 1901 to 1906. Rothaupt. Water rents and city taxes from 1930 to 1939 were kept in the name of Anna G. Menges for payment on 68 Bassett Street. Water rents and city taxes for 1926 to 1939 were kept by Dora C. Rothaupt for payments on 11 Bohl Avenue. Dora also paid for street improvements made at 11 Bohl Avenue during the year of Her relationship to this address is not known. The 1926. address is not listed in the Albany City Directory during this time.

Many of the individual items which make up this collection may appear initially to be of no consequence. The pieces alone do not hold much information. Articles such as receipts and bills are thrown away in many homes over the years. Collectively, however, the items document over forty years of an average family household in the city of Albany from 1898 to 1944.

Lackawanna Anthracite Coal, 145 Dongan Ave., Est. 1885, and R. B. Rock, Established 1885, Dongan & Cherry St., Albany, N.Y.. Receipts date from 1907 through 1938.

- John C. Manifold, Dr., Plumbing and Heating, 46 Bertha Street. Receipt dated Dec. 31, 1936. Accompanied with a paid receipt from Hoy & Co., Inc., 39-41 Columbia Street, Albany, N.Y., and a letter containing a certificate of approval by the New York State Fire Insurance Rating Organization for installation of an oil burner at 68 Bassett Street. Also included with this are receipts from the Standard Oil of New York division of Socony-Vacuum Oil Company, Inc., Albany, N.Y.. Bills made out Mrs. Menges and E.B. Shaper, Emp. Franklin and Bassett Streets, Albany, N.Y..

#### RENOVATION AND CONSTRUCTION RECEIPTS

Held, Paperhanging, Painting and Tinting, 79 Hamilton Street.

- To William L. Goetze, Dr., Carpenter and Builder, Jobbing Promptly Attended To, Estimates cheerfully furnished, 52 Plum Street. For work done at 78 Cherry Street and 68 Bassett Street. Both paid for by Menges. Also included an agreement to build a two-story frame addition at 68 Bassett Street and other carpentry for seven hundred dollars. Work done from June 1910 through Sept. 1910.

Receipts also read To Welsh and Grey, Dr., Lumber Dealers, and The Welsh & Grey Lumber Co., Lumber, Timber, Lath, and Shingles, Sash, Doors, Blinds, 66 to 72 Fourth Avenue, Albany, N.Y., and Welsh & Grey Lumber Corporation, Lumber, Sash, Doors, Nails, Shingles, Roofing, Wall Boards., 62 to 72 Fourth Avenue, Albany, N.Y.. Work done at Bassett Street.

- Joseph O. Stapf, Dr., Plumbing and Roofing, Repairing given prompt attention, 144 Broad Street. Receipts date from 1910 through 1933. Receipts are also titled Joseph O. Stapf, Dr., Plumbing, Roofing and Heating, 3 Third Avenue, cor. Clinton Street., and 25 Third Ave., cor. Clinton Street. Work done at Cherry Street and Bassett Street.
