## **ALBANY INSTITUTE TO HONOR E. STEWART & KIMBERLY JONES AT 2014 MUSEUM GALA**

ALBANY, NY– The Albany Institute of History & Art will host its biggest event of the year, the 2014 Museum Gala, on the evening of Friday, June 6, 2014. The Board of Trustees of the Albany Institute is dedicating this year’s gala to Kimberly and E. Stewart Jones, Jr. for their philanthropic support of our community.

“Kimberly and Stewart’s philanthropic commitment to the Capital Region has created a lasting legacy for future generations,” says George R. Hearst, III, the Chair of the Board of Directors at the Albany Institute. “We wish to thank them for their hospitality, generosity, enthusiasm, and vision.”
